Mail Safety and Security

In light of the recent incidents in Texas, we wanted to share some tips with you on how to keep your Operations and Employees safe and secure:

- Be looking for packages that are not expected, things that have not been ordered by procurement or supply departments.
- Items that are received for personnel who do not normally receive packages.
- Non-descript markings no return address, sloppy handwriting, the characteristics as shown in USPS Poster

- Review the return address to make sure it is from a location that is recognized and "trusted" (those of us in the mail screening arena have no trusted sources, ever)
- Use double gloves on personnel handling mail; if you can open the mail as far from the interior of the building the better; inspect on a loading dock if possible. Sounds like you have a central location for mail intake
- Employee education and awareness are crucial

From what we have read on the Austin bombings, the bomber did in fact use the carriers, shipping his devices, and that they were victim operated (so that when the recipient opened the package it detonated as the circuit was completed.)

Anything on a package that seems odd (a package that should be light but is heavy) is a big red flag. Obvious signs like oily stains, wires, residue, noises - clear the area and initiate response protocols. Until we learn more on the design of his packages we don't know if remote detonators like cell phones were used. These are often used when a package is shipped with a tracking number as the bomber has confirmation from the shipper that the package has been delivered; he then calls the cell phone included in the package which acts as a switch and detonates the package. Based on what law enforcement releases, we may not know for sure what was included in the devices.

ACCORDING TO SALLY The Importance of Mail

Today's mail centers not only sort and deliver the inbound mail but are also challenged to ensure that all items entering the building are free from mail-borne threats. Many facilities include access point security guards and x-ray technology as safeguards against harmful items entering the building through laptop bags, purses, and totes but mail and parcels are not permitted to be screened through these check points. The mail center staff are expected to perform stand-alone inspections of all items introduced into the facility through the mail center.

With the trend towards reducing administrative budgets (where most mail center funds reside), mail center managers are feeling the pressure to provide the technology and training to meet the security requirements without the available funding for a fully fashioned strategy. In the Federal sector, there are many publications that outline mail screening directives such as the 41 CFR 101-9 Federal Mail Management, the 41 CFR 101-192 Federal Management Regulation Mail Management, the GSA Mail Center Security Guide, and the United States Postal Service's Best Practices for Mail Center Security. These documents provide valuable content on the importance of mail screening but do not define a clear method of developing and deploying a mail center security program.

So if mail centers are supposed to have comprehensive security procedures in place with little direction on how to develop them, and most likely limited financial resources, how can a viable plan be executed? A good place to start is through leveraging industry contacts. Consider the following ideas to bolster your mail center security initiatives:

- Leverage your MSMA contacts. Connect with your fellow MSMA members who are subject matter experts in mail screening. They will be happy to discuss your needs for technology, training, and outsourced options. Additionally, many MSMA members are in positions of operational mail center management and have experience in the application of mail security plans within their own facilities. Touch base with these individuals and ask for advice on the techniques they used and the results they have experienced when deploying a mail security program.
- Attend MailCom and MSMA educational sessions to gain valuable knowledge and training on mail screening and safety techniques.

- Create a Building Security Committee. If your mail center is located in a multi-tenanted facility, consider establishing
 a security committee comprised of a representative from each tenant. Develop suggestions for a centralized point of
 entry for all inbound mail, including screening procedures, and present it to the building manager as an "insurance
 policy" against a facility guarantine should an active mail threat be realized.
- Collaborate with Building Security. Reach out to those in charge of physical facility security to coordinate response
 efforts in the event of a mail-borne threat. Establish threat response protocols, incident points of contact, evacuation
 assembly locations, and drill schedules collectively with facility security stakeholders to encourage a comprehensive
 approach to overall building and personnel safety.
- **Consider used equipment**: X-ray technology suppliers offer used or refurbished units with the same functionality as new units (typically these "pre-owned units" are turned in at the end of a lease or as the result of a company upgrade). When coupled with initial training, a maintenance plan, and annual refresher courses, these units stand to provide a mail screening solution that is both cost effective and technologically sound.

Mail screening is no longer an option – it is a necessary component of every mail center environment. With a little research, some networking, and collaboration, the development of a comprehensive security plan will be a seamless and valuable part of your mail center operation.
